Re: Resentencing Motion for Domestic Violence Survivor Deatrice Morris

Dear District Attorney Katz:

We, the undersigned organizations, strongly support the resentencing application of Deatrice Morris under the Domestic Violence Survivors Justice Act (DVSJA).

In 2013, Ms. Morris's abusive intimate partner, Lonnie Diggs, coerced her into serving as an unwilling accomplice to the murder of Franchesco Morales-Rodriguez. A forensic psychiatrist who evaluated her before trial concluded that Ms. Morris was the victim of extreme intimate partner violence who had participated in the killing of Mr. Morales-Rodriguez under duress – which, under New York law, would have been a complete defense. Furthermore, Ms. Morris cooperated fully and expressed remorse. N evertheless, she was treated harshly by your predecessor as District Attorney, given a 15-year prison sentence and required to plead guilty to manslaughter. In contrast, Diggs, her abuser, was allowed to plead to a non-homicide offense and receive a shorter sentence.

The passage of the DVSJA codified our collective mission to raise awareness and understanding of how a background of trauma and abuse cannot be ignored within the criminal legal setting. The DVSJA was intended to be a landmark piece of legislation, extending a degree of leniency to survivors across a broad range of offenses, including crimes against third parties, as was the case here. We are disappointed that in the almost two years since the statute's enactment, there have been no resentencings in Queens County.

Ms. Morris has served more than seven years of her sentence. She has a supportive family and is ready to come home. She is a domestic violence survivor and is precisely who the DVSJA was intended to benefit. Those of us who have been working for many years to end gender-based violence urge you to consent to resentencing in this case.

Thank you for your consideration. We all look forward to welcoming Deatrice home.
